Annex 5: General Terms and Conditions for Services

1.0 LEGAL STATUS:

The Service provider shall be considered as having the legal status of an independent service provider vis-à-vis the SUVIDHA.

2.0 SOURCE OF INSTRUCTIONS:

The service provider shall neither seek nor accept instructions from any authority external to SUVIDHA in connection with the performance of its services under this Empanelment. The Service provider shall refrain from any action that may adversely affect SUVIDHA and shall fulfill its commitments with the fullest regard to the interests of SUVIDHA.

3.0 ASSIGNMENT:

The service provider shall not assign, transfer, pledge or make other disposition of this Empanelment or any part thereof, or any of the Service provider's rights, claims or obligations under this Empanelment except with the prior written consent of SUVIDHA.

4.0 SUB-EMPANELMENTING:

In the event the Service provider requires the services of sub-service providers, the Service provider shall obtain the prior written approval and clearance of SUVIDHA for all sub-service providers. The approval of SUVIDHA of a sub-service provider shall not relieve the Service provider of any of its obligations under this Empanelment. The terms of any sub-empanelment shall be subject to and conform to the provisions of this Empanelment.

5.0 OFFICIALS NOT TO BENEFIT:

The Service provider warrants that no official of SUVIDHA will be offered by the Service provider any direct or indirect benefit arising from this Empanelment or the award thereof. The Service provider agrees that breach of this provision is a breach of an essential term of this Empanelment.

6.0 USE OF NAME, EMBLEM OR OFFICIAL SEAL OF SUVIDHA OR CSR ORGANISATION WHOSE PROJECTS ARE BEING ASSESSED:

The Service provider shall not advertise or otherwise make public the fact that it is a Service provider with SUVIDHA, nor shall the Service provider, in any manner whatsoever, use the name, emblem or official seal of SUVIDHA, or any abbreviation of the name of SUVIDHA **OR CSR ORGANISATION WHOSE PROJECTS ARE BEING ASSESSED** in connection with its business or otherwise.

7.0 CONFIDENTIAL NATURE OF DOCUMENTS AND INFORMATION:

Information and data that is considered proprietary by either Party and that is delivered or disclosed by one Party ("Discloser") to the other Party ("Recipient") during the course of performance of the Empanelment, and that is designated as confidential ("Information"), shall be held in confidence by that Party and shall be handled as follows:

8.0 TERMINATION

8.1 Either party may terminate this Empanelment for cause, in whole or in part, upon thirty (30) days' notice, in writing, to the other party.

8.2 SUVIDHA reserves the right to terminate without cause this empanelment at any time upon 15 days prior written notice to the Service provider, in which case SUVIDHA shall reimburse the Service provider for all reasonable costs incurred by the Service provider prior to receipt of the notice of termination.

8.3 In the event of any termination by SUVIDHA under this Article, no payment shall be due from SUVIDHA to the Service provider except for work and services satisfactorily performed in conformity with the express terms of this Empanelment.

8.4 Should the Service provider be adjudged bankrupt, or be liquidated or become insolvent, or should the Service provider make an assignment for the benefit of its creditors, or should a Receiver be appointed on account of the insolvency of the Service provider, the SUVIDHA may, without prejudice to any other right or remedy it may have under the terms of these conditions, terminate this Empanelment forthwith. The Service provider shall immediately inform the SUVIDHA of the occurrence of any of the above events.
