Empanelment proposals shall be reviewed and evaluated based on completeness and compliance of the proposal and responsiveness with the requirements of the advertisement and all other annexes providing details of SUVIDHA requirements.

The empanelment proposal that complies with all of the requirements, meets all the evaluation criteria and offers the best value for money shall be selected and awarded the empanelment. ## 2. Duration of empanelment

The empanelment shall remain effective for 1 year from the date of empanelment.

## 3. Qualifications of the firm for Micro Capacity Assessment

The offeror is required to provide a brief overview of the company detailing its activities, registration, audit reports, area of expertise, relevant certificates concerning the product, evidence of deployment of similar projects, if any, and any other information that shows the company's reliability, financial and managerial capacity to provide the required goods.

## 4. Warranty, After Sales & Operation and Maintenance Services

The successful offeror would be required to provide a minimum warranty of 1 year. Further to this, after sales services including maintenance, training on operation and gathering of data for the product should also be provided for a minimum of 2 months for each product disseminated. The successful offeror should ensure that each product sold has a minimum of 1 years after sales services.

## **Technical Requirements for Efficient Cook-stoves**

#### Part-B

## 1. Fuel Requirements

Unless otherwise specified, only cook-stoves employing traditional fuel available in rural landscape i.e., wood, crop residue, cow dung etc. would be accepted.

#### 2. Size of the Cook-stove

Unless otherwise specified, the cook-stoves should be sized to accommodate use of up to 10 L cooking pots. This detail should be clearly mentioned in the product documents.

## 3. Applicable Standard(s)

Unless otherwise specified, the product should conform to guidelines published by the International Standards Organization (ISO) as IWA 11:2012 *Guidelines for evaluating cook-stove performance*.

The bidders may specify any other relevant standard which could satisfy the acceptable quality level of the product as specified in IWA 11:2012.

## 4. Specifications

The cook-stove must meet the following requirements/specifications:

- Minimum 30% wood fuel efficiency
- Challah MNRE Approved
- 50% less emissions of particulate matter and carbon monoxide as compared to traditional challahs.
- 50% less Indoor Emissions as compared to traditional challahs.
