## 3.0 ASSIGNMENT:

The service provider shall not assign, transfer, pledge or make other disposition of this Empanelment or any part thereof, or any of the Service provider's rights, claims or obligations under this Empanelment except with the prior written consent of SUVIDHA.

## **4.0 SUB-EMPANELMENTING:**

In the event the Service provider requires the services of sub-service providers, the Service provider shall obtain the prior written approval and clearance of SUVIDHA for all sub-service providers. The approval of SUVIDHA of a sub-service provider shall not relieve the Service provider of any of its obligations under this Empanelment. The terms of any sub-empanelment shall be subject to and conform to the provisions of this Empanelment.

#### 5.0 OFFICIALS NOT TO BENEFIT:

The Service provider warrants that no official of SUVIDHA will be offered by the Service provider any direct or indirect benefit arising from this Empanelment or the award thereof. The Service provider agrees that breach of this provision is a breach of an essential term of this Empanelment.

# 6.0 USE OF NAME, EMBLEM OR OFFICIAL SEAL OF SUVIDHA OR THE UNITED NATIONS:

## 8.0 TERMINATION

- **8.1** Either party may terminate this Empanelment for cause, in whole or in part, upon thirty (30) days' notice, in writing, to the other party.
- **8.2** SUVIDHA reserves the right to terminate without cause this empanelment at any time upon 15 days prior written notice to the Service provider, in which case SUVIDHA shall reimburse the Service provider for all reasonable costs incurred by the Service provider prior to receipt of the notice of termination.
- **8.3** In the event of any termination by SUVIDHA under this Article, no payment shall be due from SUVIDHA to the Service provider except for work and services satisfactorily performed in conformity with the express terms of this Empanelment.
- **8.4** Should the Service provider be adjudged bankrupt, or be liquidated or become insolvent, or should the Service provider make an assignment for the benefit of its creditors, or should a Receiver be appointed on account of the insolvency of the Service provider, the SUVIDHA may, without prejudice to any other right or remedy it may have under the terms of these conditions, terminate this Empanelment forthwith.
